

Seminar Concept

The polity of India works within the framework of the Constitution. India has travelled a long path since the British exited in 1947. At a time when most developing countries opted for authoritarian models of governance to promote nation building and economic development, India chose to build a multi-party democracy. Nehru, the architect of modern India, laid great emphasis on building the institutions of democracy as well as the creation of development mechanism. Since then India has evolved into a vibrant constitutional democracy and made rapid strides in several domains though, there exists ample room for improvement.



Democracy is always interrelated with economy. India's economic system has gone through multiple experiences and challenges. Nehru's mixed economic model has gradually transformed into free market economic model with the help of external capital or FDI. After 1991, when India introduced NEP welcoming the globalization, then political economy of India got a new impetus. A number of unfolded and age old issues took entry in India's democratic milieu in new manners and new directions. With the introduction of LPG project, on the one hand, a modern digital technological advance India has emerged, on the other hand political corruption, illegal money laundering in politics, gender discrimination issue, and corporatization in education system, environmental issues, parochial political culture and others important issues have been injected in India's democratic system. After 1991, with the changes of India's global outlook with aspiration to be an emerging power has started to interact with several international, regional organizations and countries with complex calculus. India's foreign policy orientation has transformed from idealistic to realistic after the collapse of erstwhile USSR. Today, India has been successfully projected itself as a big potential market with a sizable middle class. Being a largest democracy in the World, it a great challenge to India to establish qualitative democracy as well as to ensure economic diversity.
