In continuation to this office communication number 12-Pr.Secy-HED/2020 dt.30.05.2020 and No.15-Pr.Secy-HED/2020 dt.23.06.2020 on the subject, I am directed by the competent authority in the Government of West Bengal to convey that all Government, Government aided, private educational institutions, training institutions including hostels, will remain closed upto 31st August, 2020, in public interest.
