# **NOTIFICATION**

Sub: Circular no 11 of 2021 of Government of India, Ministry of Finance, Central Board of Direct Taxes regarding use of functionality under Section 206AB and 206CCA of the Income Tax Act, 1961

It is hereby notified for information to all Suppliers, all Contractors, all Vendors, all Service Providers, all Agencies and all Other Payee ,who wish to receive payment from Cooch Behar Panchanan Barma University under any contract or obligation other than Salary, Pension, Honorarium, remuneration and reimbursement payment.

Finance Act, 2021 inserted two new sections 206AB and 206CCA in the Income Tax Act 1961which takes effect from 1<sup>st</sup> day of July,2021. These sections mandate tax deduction (u/s 260AB) or tax collection (u/s 206CCA) at higher rate in case of certain non-filers (specified persons) with respect to tax deductions in the sections specifically 194C,194I & 194J. and tax collections.

Hence, We have to obtain information from the all Suppliers, all Contractors, all Vendors, all Service Providers all Agencies and all Other Payee whether they have filed ITR for previous two years i,e for Financial Year 2018-2019 and 2019-2020.

All concerned ate now requested to submit a **DECLARATION FORM** (attached here with) through email (<u>fo.cbpbu@gmail.com</u>) scan copy and original to the Office of the Finance Officer otherwise we will be compelled to deduct tax at higher rates, under section 206AA and/ or 206AB of the Act.

Initially, we are holding all such payments till we receive declaration form the payees.

All are requested to submit the declaration form immediately, to help in the payment process, by complying the legal requirements.
