TERMS & CONDITIONS FOR BOOK SUPPLIERS / VENDORS

- 1. Application fee of **Rs. 1000**/- must be paid along with the Application Form (payable to: Cooch Behar Panchanan Barma University, SBI A/c No. 32741316141, IFSC: SBIN0000058).
- 2. Successful vendors must deposit **Rs. 10,000/-** as Earnest Money (refundable).
- 3. Security Money @ 8% of bill value will be retained and refunded after 3 months of satisfactory supply.
- 4. Quotations will be invited from enlisted vendors, but the University may procure from others if required.
- 5. Enlisted vendors must submit quotations when asked.
- 6. Non-compliance may lead to cancellation of enlistment.
- 7. Enlistment valid up to 31/10/2026, extendable at University's discretion.
- 8. University reserves the right to accept/reject any application and cancel enlistment.
- 9. Only latest editions/reprints must be supplied.
- 10. Indian edition must be supplied if available.
- 11. If low-priced/special Indian edition exists, that must be supplied.
- 12. Imported books must be confirmed within 2 weeks of Purchase Order.
- 13. Failure to supply at least 80% of ordered books may result in blacklisting.
- 14. Ready-stock books must be supplied within 1 week.
- 15. Imported books must be supplied within 4 weeks (POD: 6–8 weeks).
- 16. If new edition is upcoming, vendor must inform and supply the latest edition within 4–6 weeks of release.
- 17. Exchange rates must match RBI/GoC rates on date of Purchase Order (with certified copy).
- 18. Publisher/Importer's invoice copies must be enclosed for price verification.
- 19. Any discrepancy found must be rectified immediately (refund or replace).
- 20. Vendors must be members of registered trade bodies (AIPB/FPBA/PBSAB etc.).
- 21. Vendors must be serving major libraries (University, Govt., and Research Institutions).
